**AGREEMENT TO ARBITRATE**

For good consideration, the undersigned parties hereby agree to submit a dispute to a binding arbitration proceeding with the Center for Legal Solutions.

1. ARBITRATION PROCESS. Arbitration is an adversarial procedure resulting in an Award by the Arbitrator.

2. GOOD FAITH. By signing this agreement, all parties pledge to cooperate and participate in good faith in all Arbitration proceedings.

3. ARBITER'S ROLE. The Arbitrator will act as a judge and will not offer legal advice. The Arbitrator will be neutral and impartial. The Arbitrator's opinions and Award SHALL be binding on all parties.

4. SCOPE OF ARBITRATION. The undersigned parties agree that all issues currently pending between them shall be submitted to arbitration. Any issue that may be asserted that the parties do not agree to submit to arbitrating must be specified:

Should applicable domestic relations laws provide the parties the right to seek modification of the Arbitration Award, the undersigned parties [AGREE] [DO NOT AGREE] to arbitrate modification actions under these Rules.

5. SELECTION OF ARBITRATOR. The undersigned parties have selected \_\_\_\_\_ as their Arbitrator. In the event that the parties have not agreed upon an Arbitrator or their chosen Arbitrator is unable to serve, an Arbitrator shall be selected pursuant to the Rules.

6. HOLD HARMLESS. The parties hereby agree to fully indemnify, reimburse and hold the Arbitrator and the Center for Legal Solutions harmless, from any

and all damages, claims, judgments, cost and expenses, including attorney fees, incurred by the Arbitrator or the Center for Legal Solutions as a result of any subsequent claim, demand or cause of action arising from this arbitration, whatsoever.

7. GUIDELINES AND RULES. Center for Legal Solutions' Rules for Arbitration shall control this Arbitration. In cases involving minor children, Additional Rules for Domestic Relations Arbitration Proceedings Involving Children shall apply.

Should the parties elect to follow Additional Rules for Arbitration Proceedings Involving Complex Matters or Multiple Parties, they shall notify Center for Legal Solutions of such election in writing.

8. ADMINISTRATION COST AND ARBITRATION FEES. The fees and expenses for the Arbitration shall be in accordance with the Center for Legal Solutions' Rules for Arbitration. *The Arbitration Award will not be published to any party until Center for Legal Solutions has received full payment for all invoices resulting from this case.*
